The North Carolina Museum of Art Foundation, Inc. provides the majority of financial support needed for education and curatorial programming of the Museum of Art including support for statewide and museum-based education programming, special traveling art exhibitions, supplemental art conservation funds, and public programming.

	The North Carolina Museum of Art Foundation, Inc. provides additional support to the Museum of Art by cultivating donors for commissioned works of art and contributions for art acquisitions. The investment policy was developed with the long-term interests of the endowment in mind and adheres to accepted investment and financial management principles. The investment policy is designed to ensure prudent management of the assets in order to serve the best long-term interests of the Foundation. The Foundation expects its endowment funds, over time, to provide a total real rate of return of 5%, net of fees, over a three-year rolling average. Actual returns in any given year may vary from this amount. While the Foundations historical spending policy reflects an intended appropriation of 5% of the endowment funds for distribution each year in keeping with the anticipated investment return, the board closely monitors anticipated investment returns relative to current market conditions each year. Effective July 1, 2016, the board amended its spending policy to reflect a 4% distribution of assets annually. While the stated goal of earning at least 5% annually has not been revised, any investment returns in excess of the revised annual distribution of 4% will remain invested in the endowment and will earn additional returns until appropriated in future years.

In addition to salary supplements, the Foundation maintains a consulting agreement with Dr Wheeler which provides additional compensation in exchange for his expertise and involvement in various fundraising activities, particularly as they relate to the cultivation and solicitation of collectors and donors. The most recent consulting agreement commenced on July 1, 2015 and is for a two year period ending June 30, 2017. Under this agreement, Dr Wheeler receives quarterly consulting fees, semi-annual retention fees, and the services of a third party financial planning consultant paid by the Foundation.
