SHELTERCARE PROVIDED EMERGENCY SHELTER AND SUPPORT SERVICES TO 35 HOMELESS FAMILIES WITH CHILDREN AND PROVIDED HOMELESSNESS PREVENTION SUPPORT AND SERVICES TO 189 FAMILIES INCLUDING THOSE IN THE CHILD WELFARE SYSTEM. SHELTERCARE'S HOMELESS MEDICAL RESPITE PROGRAM SERVED 105 INDIVIDUALS. BENEFITS OF THE PROGRAMS FOR FAMILIES INCLUDE: (A) 53% OF PERSONS IN TRANSITIONAL HOUSING EXITED TO PERMANENT HOUSING DURING THE YEAR, (B) 43% OF PERSONS AGE 18 OR OLDER INCREASED THEIR TOTAL HOUSEHOLD INCOME FROM ALL SOURCES DURING THE YEAR, WHILE AN ADDITIONAL 39% REMAINED STABLE IN THEIR INCOME LEVELS, AND (C) 97% OF PARTICIPANTS ELIGIBLE AND NEEDING MAINSTREAM BENEFITS WERE ENGAGED IN THE APPLICATION PROCESS FOR EVENTUAL RECEIPT OF THOSE BENEFITS. 
