Currently the Treasurer of the Foundation is a faculty professor with the authority to approve grants to faculty and students and distribute scholarship funds to the University. Requests for faculty research and travel support and student support are first approved by the Dean of the School of Business Administration or his designee. Student scholarship recipients are recommended by the Stetson University School of Business Administration faculty and/or the Stetson University Office of Financial Planning.

Previously two of the Foundation board members served consecutively as Vice President of Finance for the University.

The Stetson Business School Foundation provides that service for Stetson School of Business Administration students and professors.
