Early Intervention Program - Provide services to children ages birth to three years old with developmental delay or disability. Over 250 developmentally delayed infants and toddlers receive early intervention through the Community Development Center. Services to children ages birth to three years of age are provided in a home community-based setting. Approximately 41 percent of children who received services through the Community Development Center were able to continue preschool services with the local school system. Early intervention services provided by the CDC include specialized instruction to children, family training and family consultation.

4b (Code:) (Expenses \$ 863249 including grants of \$) (Revenue \$)
Independent Support Coordination Program - The ISC program coordinates services for individuals, primarily adults, with intellectual and developmental disabilities who are enrolled in the 1915 (c) Medicaid Waiver. Individuals supported by the ISC of the Community Development Center include those living in thirteen South Central Tennessee counties. The ISC program currently services over 300 clients. The service areas of the program include education, development, medical and living coordination.

Family Support Program - Provides flexible financial support to households with a member with severe or developmental disability. A severe or developmental disability which is attributable to a mental and/or physical impairment, which is likely to continue indefinitely, and results in substantial limitations in at least three major life functions. Support services include Respite or Sitter, Day Care, Home Modifications, Transportation, Homemaker Services, Housing Costs, Specialized Equipment & Modifications, Nutrition, Clothing & Supplies, Personal Assistance, Family Counseling, Health Related Nursing Care, Summer Camp, Medical Travel and Evaluation.
