ALTHOUGH THE COLLEGE DOES NOT CONTROL THE TIMING OR AMOUNT OF RECEIPTS FROM THE FOUNDATION, THE MAJORITY OF RESOURCES, OR INCOME THEREON THAT THE FOUNDATION HOLDS AND INVESTS ARE RESTRICTED TO THE ACTIVITIES OF THE COLLEGE BY THE DONORS. THE ORGANIZATION PROVIDED SCHOLARSHIP SUPPORT TO APPROXIMATELY 1,007 STUDENTS VALUED AT 663,032. IN ADDITION IT PROVIDED SUPPORT FOR AWARDS, PROGRAMS, AND RELATIONS VALUED AT 1,217,811 TO SAN JUAN COLLEGE.
