UFM Community Learning Center is a creative educational program serving Kansas State University, the Manhattan, KS area and the state of Kansas. UFM provides opportunities for lifelong learning and idea exchange. UFM also serves as a catalyst and host for new programs and services than enhance the quality of life for all.

UFM Educational Program: this is UFM's largest program and primary mission activity. The educational program offers a wide variety of noncredit and credit courses and workshops. In FY16, UFM offered 755 noncredit classes and 267 courses offered for credit through Kansas State University. 3,103 (unduplicated) persons took noncredit classes and another 2,168 students received K-State credit. Class topics included aquatics, creative free time, foods and nutrition, earth and nature, health and wellness, recreation, languages and martial arts. Total participation in UFM activities was 14,734.
UFM is the sole Licensed Training Provider for the American Red Cross in the Manhattan area and is the largest provider in Kansas. UFM collaborates with many other organizations to serve the community and participated in several community awareness activities.

UFM continued to host Osher Lifelong Learning Institute classes in collaboration with the University of Kansas and K-State Global Campus. This year we had 825 enrollments in 15 classes and 6 special events.

UFM hosted the Community Campaign for Nonviolence and the Flint Hills Renewable Energy and efficiency Cooperative offices as a community service.

4b (Code:) (Expenses \$ 96,865 including grants of \$ 0) (Revenue \$ 83,550)
Manhattan Area Risk Prevention Coalition (MARPC). UFM receives and administers funds on behalf of MARPC, a coalition of 12 community sector representatives. The focus of the coalition is risk reduction and prevention among youth, especially alcohol/drug use issues and prevention activities. In FY16, MARPC received the fourth year of grant funding from the Kansas Dept. of Aging and Disability Services. The focus of this grant is a media campaign on social hosting and messages on ways parents can talk to their children about alcohol use.
MARPC also received a small grant to host trainings on teen suicide prevention. One training took place as part of the Manhattan High School teacher inservice in August. A second training was offered to the community.
MARPC continued to host the Manhattan High School After Prom Party.
MARPC coordinated Sticker Shock events in Manhattan and at Fort Riley. About 50 volunteers put stickers, focused on not providing alcohol to minors, on 10,000 packaged goods in liquor stores.

Teen Mentoring Program: The Teen Mentoring Program offers a structured program of support and life skills to youth in grades 7-12. Project goals for the teens include learning positive life skills and focusing on primary prevention and intervention activities. Students from Kansas State University serve as mentors. Participant referrals come from the schools, community corrections, parents and teen participants who bring their friends. In FY16, due to increased participation, the program was expanded to three days. 40 youth were served and 23 K-State students served as mentors.

Part III. 4d 1. Manhattan Community Garden Expenses - \$5,703 Grants - \$0 Revenue - \$14,636

Low cost garden plots are available to Manhattan and Riley County residents. Print newsletters are produced three times during the growing season. An e-newsletter is sent weekly. Power tools, some hand tools and hoses are provided. Land is leased from the City of Manhattan and Riley County. In FY16, 182 families gardened 280 plots. Excess funds were set aside for future garden development and equipment purchases.

Part III. 4d 2. Project EXCELL (Extending College Education for Lifelong Learning). Expenses - \$11,561 Grants - \$0 Revenue - \$16,557

Project EXCELL provides area adults with mild developmental/intellectual disabilities enrichment and job readiness classes in a college-like environment. Traditional college students serve as mentors and classroom aids. Classes are held on Saturday mornings during the fall and spring semesters. In FY16, 62 participants enrolled and 33 KSU students assisted. Excess funds were carried over to the FY17 year when grant funds and donations are anticipated to be down.

Part III. 4d 3. Lou Douglas Lectures. Expenses - \$7,283 Grants - \$0 Revenue - \$9,438

This lecture series brings speakers to the K-State Campus. The overall theme of the series is social justice, human rights, world peace and international development. In addition to lectures, the speakers often visit K-State classes, meet with student groups and, when appropriate, participate in campus and community events. In FY16, speakers included Duane Goossen, speaking on the state of the Kansas budget, and Thomas Frank, author of "What's the Matter with Kansas?"

This project provides referrals and financial assistance to qualified adoptive families. This project had no activity in FY16.
