TAX INDEMNIFICATION & GROSS UP PAYMENTS - Tax gross-up payments, considered taxable compensation, were provided to 10 officers and key employees listed in Part II of Schedule J for one or more of the following items: (a) years of service recognition awards or (b) gift certificate award.
