THIS PROGRAM WAS ESTABLISHED IN JANUARY 2005 PINNACLE HEALTH INFECTIOUS DISEASE ASSOCIATES SPECIALIZES IN THE TREATMENT OF ANY ORGAN INFECTION AND INFECTIOUS DISEASES INCLUDING, BUT NOT LIMITED TO, OSTEOMYELITIS, LYME DISEASE, MENINGITIS, HIV, AND HEPATITIS C BOTH INPATIENT AND OUTPATIENT SERVICES ARE PROVIDED, INCLUDING A TRAVEL CLINIC PINNACLE HEALTH PALLIATIVE CARE -
