H2O for Life Schools provided \$324,471 for implementation of WASH in Schools projects for partner schools around the world. Our funds are matched by our implementing partner, for a global impact of \$648,942. 175 U.S. schools participated in our program, reaching more than 87,500 students during 2015-16 with projects implemented in 75 schools providing water and sanitation for 22,500 students. Our local water conservation of water program piloted in 2 school districts engaged an additional 8,800 youth to learn about local water, and received the Environmental Initiative Award for Best Environmental Education Program in the state of Minnesota.
