The eighth annual Tucson Festival of Books was held March 13 and 14, 2016 on the University of Arizona campus. Authors, exhibitors and book lovers of all kinds attended the Festival which attracted approximately 135,000 people to the UA campus and raised \$212,000 to advance literacy and education in Southern Arizona. The 2016 Festival attracted more than 370 authors, 275 exhibitors and staged a multitude of activities: hundreds of presentations and discussions, workshops for aspiring authors, book signings, free book give-away distribution of 6,000 titles in the Childrens area, dozens of hands-on activities were conducted in Science City, and much, much more. Three special events took place in 2016 - 1) Shakespeares First Folio! was on display and had several authors / panels devoted to the Bard, 2) Tucsons Big Read - celebrating Edgar Allan Poe - offered a couple of programs at the Festival, and 3) The 100th Anniversary of the National Parks System set a stage for several programs. Approximately 2,000 volunteer jobs are filled annually to assist with managing the event during the weekend.
