In fiscal year 2015/16, more than 2,200 patients were enrolled in the HealthNet. The organization coordinated 7,862 medical visits and 1,631 mental health therapy appointments. Safety net pharmacies dispensed almost 26,000 prescriptions to HealthNet patients. Additionally, the HealthNet referred patients for 425 dental, and 2,035 diagnostic appointments.
