THE CORE WORK OF GMFB IS THE COLLECTION AND DISTRIBUTION OF DONATED FOOD AND OTHER GROCERY PRODUCTS TO CHARITABLE AGENCIES IN A FIVE COUNTY SERVICE AREA IN NORTHEAST GEORGIA, INCLUDING DAWSON, FORSYTH, HALL, LUMPKIN AND UNION COUNTIES, SERVING LOW-INCOME AND NEEDY PEOPLE. GMFB SUPPLEMENTS DONATED AND SURPLUS FOOD AND PRODUCTS WITH THE PURCHASE OF SPECIFIC FOOD AND GROCERY ITEMS. ON A MONTHLY BASIS APPROXIMATELY 22,000 INDIVIDUALS ARE SERVED IN THE GMFB SERVICE AREA THROUGH PARTNER AGENCIES.
