The Big Valley Water Polo Academy continued to grow in both number of athletes and programs offered. We also have established a very strong fund-raising schedule for the calendar year. We have included a Summer Fund-raising Dinner, and established the Golden State Invitational, which has become a USAWP signature event. We were able to qualify nine teams to the annual summer national championships in the San Jose Bay Area. This was four more teams than the previous year. Our highest finish was the 16U girls who placed 14th in the Platinum Division. This was the first time in club history that the highest placed squad was a female team. The club rentals at St. Mary's HS and Delta College pools for training purposes have increased. We have also increased the number of pool we utilize for competitions to include, University of the Pacific, Stagg High School, Lincoln HS, Bear Creek HS, and Tokay HS pools. The club continues to do clinic series, which bring in coaches and athletes to our area to provide elite level clinics for our members and interested athletes and coaches from our area.
