Here, the majority of its support came from persons and organizations passionate about the Foundation's charitable purpose, not from members of a single family. It is further relevant that neither the Foundation's founders nor board members are major financial contributors, another sign that the organization is publicly supported.

(C) Treas. Reg. § 1.170A-9(f)(3)(iii)(C): An additional factor weighing in favor of an organization being publicly supported is the fact that the organization's governing body represents the broad interests of the public, rather than the private interests of a few. The Foundation's board of directors represents the broad interests of the public, as the board members have (i) special knowledge in the Foundation's field of operation and (ii) represent a broad cross-section of the views and interests of the community. More specifically, the Foundation's stated purpose is to provide enhancement funding to the Margaret Talkington School for Young Women Leaders, a single-gender public school in the Lubbock Independent School District open to female students grades six through 12 who show a commitment to leadership, education, and college attendance, most of whom are economically disadvantaged. Kitty Harris, the Foundation's president, has spent over a decade in academia, and as a result she has the special knowledge that the regulations consider evidence of an organization's status as a public charity. Also, the remaining board members, all of whom are unrelated, represent a broad cross-section of the views of the community: Christy McClendon works in commercial real estate, David Alderson is the owner of a local auto dealership, and Mark Griffin is the

president of an oil and gas distribution company. These three individuals, coupled with Kitty Harris, provide a mix of views representative of the community.

(D) Treas. Reg. § 1.170A-9(f)(3)(iii)(D): The final factor is whether the organization generally provides facilities or services directly for the benefit of the general public. To the extent this factor is applicable (the Foundation does not have a facility), it points in favor of the Foundation being publicly supported. While the Foundation cannot give performances to the general public like a symphony can, the Foundation does provide services to the general public through its continued funding of the Talkington School, which is a public school open to all female students in the Lubbock Independent School District.

As set forth above, the Foundation satisfies the applicable requirements of the "10%-facts-and-circumstances" test for the fiscal year ended June 30, 2015. Accordingly, even though the Foundation did not meet the 33.3% public support test or the 10%-facts-and-circumstances for the period July 1, 2015 to June 30, 2016, the Foundation is nevertheless appropriately classified as a public charity under Treas. Reg. § 1.170A-9(f)(3).
