MDCCC promotes the public purposes of higher education by connecting campuses with their communities throughout the MD-DC region. MDCCC is a membership association of college and university presidents and their institutions committed to promoting engaged citizenship as an aim of higher education. MDCCC serves its member institutions through networking, grants, resources, and programs with the goal of developing deeper campus-community partnerships.

MDCCC AmeriCops VISTA grant: MDCCC addresses and alleviates poverty in the Maryland-DC region through our federally funded MDCCC AmeriCorps VISTA Grant --> <https://www.mdccc.org/ameriCorps/vista/abstracts-15-16.html>

Through this grant we provide up to 25 full time "positions" to develop and expand anti-poverty partnerships between our higher education institution members and community-based organizations, non-profits or local schools and school systems in the region. Through data from our annual survey, we estimate that our member institutions' students contribute a minimum of \$450 million in service annually to our region. The VISTA grant alone is a value of \$1.5 million to our members. Our projects represent a smorgasbord of foci ranging from financial literacy, work force development, mentoring, veteran initiatives, ESOL programming, college access, college completion, to food security. We also develop and run a leadership and professional development program for the AmeriCorps VISTA members who are giving a year or more of their lives to build these partnerships and improve our communities.

Professional development workshops, retreats, awards, surveys and mini-grants:

Another area of our impact is providing professional development opportunities for faculty, staff, students and other constituents in our membership. We currently sponsor a Service-Learning and Civic Engagement Conference for 300+ faculty and students, annual retreats including a "Practitioners' Retreat" for engagement professionals, and numerous workshops on service-learning, grant writing, effective team building, volunteer recruitment, professional writing and (federal) report writing, etc. We provide mini-grants to member institutions to promote faculty development which enhances service-learning, building a culture of engagement on a campus, community-based learning, and rewarding the scholarship of engagement in the promotion and tenure process. We also provide competitive mini-grants for student groups which wish to expand a program with a community partner organization. Finally, we also run our annual awards program which highlights exceptional work in the area of service-learning and civic engagement as well as administering national awards and an annual national member survey.

Based on the collective agreement of 36 higher education institutions to partnering with K-12 schools and school systems to enhance the P20 pipeline for college readiness, career readiness and civic and community readiness, we convened a P20 CONNECTS Implementation Task Force. The task force works closely with K-12 partners such as the Maryland State Department of Education, the Public School Superintendents Association of Maryland and the District of Columbia Public Schools and Charter Schools to, together, discern how to better "connect the dots" at the policy-level to enhance equitable access to and completion in higher education. This task force issued a white paper on College, Career and Civic Readiness through Civic Education and a five year action plan. The work of P20 CONNECTS is moved forward through annual convenings of our member institutions' presidents and area school system superintendents. We are now mobilizing regional conversations and webinars to promote best practices.
