5. The Corporation's Certificate of Incorporation is hereby amended to effect the following amendments authorized by the N-PCL:
 - (a) Paragraph 1, stating the name of the Corporation, is hereby amended to change the corporate name as follows:
 - "1. The name of the Corporation is Ability Partners Foundation."
 - (b) Paragraph 2, relating to the type of corporation, is hereby amended to read as follows:
 - "2. The Corporation is a corporation as defined in subparagraph (5) of paragraph (a) of Section 102 of the Not-For-Profit Corporation Law (the "N-PCL"). The corporation is a charitable corporation under Section 201 of the N-PCL."
 - (c) Paragraph 3, Subparagraphs A, B, C and D stating the purposes of the Corporation, are hereby amended to expand the Corporation's purposes to include support of Finger Lakes United Cerebral Palsy, Inc., United Cerebral Palsy Association of the Rochester Area, Inc., and any organization that is or becomes a subsidiary or affiliate of Ability Partners, Inc., provided that such organization qualifies under Section 501(c)(3) of the Internal Revenue Code or corresponding provisions of any subsequent federal tax laws, to read in its entirety as follows:

(f) Paragraph 5, stating that no consent is required by Section 401 of the N-PCL is required herein, is hereby omitted in its entirety.

(g) Paragraph 6, stating the initial Directors of the Corporation, is hereby omitted in its entirety.

(h) The second time Paragraph 4 appears (note that two different paragraphs are numbered "Paragraph 4" in the original certificate of incorporation), stating the address of the Corporation for a copy of any process, is hereby renumbered to Paragraph 5 and amended to read as follows:

"5. The Secretary of State is designated as agent of the Corporation upon whom process against it may be served. The post office address to which the Secretary of State shall mail a copy of any process against the Corporation served upon him is:

"6. The following language relates to the Corporation's tax exempt status and is not a statement of purposes and powers. Consequently, this language does not expand or alter the Corporation's purposes or powers set forth in paragraph number 3.

- A. No part of the net earnings of the Corporation shall inure to the benefit of any member, trustee, director, officer of the Corporation, or any private individual (except that reasonable compensation may be paid for services rendered to or for the Corporation), and no member, trustee, officer of the Corporation or any private individual shall be entitled to share in the distribution of any of the Corporation's assets on dissolution of the organization.


