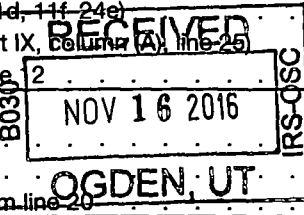

The Newberry Consort brings together singers and instrumentalists of the highest caliber to create accessible and historically informed performances of early music and provides a window into earlier times and cultures through performances, education, and research.

The Music of Johann Rosenmuller: A program of instrumental and vocal works of Johann Rosenmuller (c.1619-1684) selected from his years in Leipzig, Venice, and as Kappellmeister to the court of Braunschweig-Wolfenbittel. Three concerts performed in Chicago and Evanston, IL on October 9, 10, 11. Each concert was preceded by a talk on the history of the music and choice of selections. Participating in this concert was one of the Young Artists from the Consort's Mentorship program.

4b (Code: 711130) (Expenses \$ 22,393 including grants of \$) (Revenue \$ 12,209)

Le Roman de Fauvel: Based on a medieval poem that is a parable of ambition, greed and corruption at the French Court c.1315, the program was comprised of a selection of musical and spoken portions of manuscript fr. 146. A slide show of illustrations from the manuscript incorporated supertitle translations of the sung and spoken text. The Concert was presented three times in Chicago and Evanston, IL on January 8, 9, and 10. It was preceded by a lecture on the history of the poem, the tradition of the Feast of Fools as pre-lenten entertainment, and how selections from the manuscript were chosen and realized.

4c (Code: 711130) (Expenses \$ 26,302 including grants of \$) (Revenue \$ 11,031)

Juan de Llenas Vespers: The most well represented of the composers of the music in the Newberry Choirbooks, Juan de Llenas left enough of his works to comprise a Vesper service based on the works extant in the Mexican Choirbooks, originally composed and compiled for the cloistered nuns of the Convent of the Encarnacion in Mexico. In addition to selecting the various works and compiling them into a Vespers service, director Ellen Hargis had to recreate the missing parts of the Magnificat for 10 voices as only eight were found in the Mexican Choirbooks. The Concert was presented three times in Chicago and Evanston on April 8, 9, and 10. It was preceded by a lecture on the choirbooks as well as the process of selection and recreation. It also included the second of the Consort's young artist from their mentorship program.
