KNOM exist to provide worship, inspiration, information and education to listeners in remote Western Alaska. This mission is steeped in the values of KNOM: to be a friend and companion, provide respectful service, and honoring Catholic ideals. KNOM's listeners (numbering 20,000-30,000 people) are spread across 100,000 square miles. Most live in villages along the Bering Sea Coast and eastward to the Alaskan interior.

4a (Code: 86000) (Expenses \$ 284,577 including grants of \$ 0) (Revenue \$ 22,041)
Digital Studios Addition Capital Project continues, with occupation and full use expected in fall of 2016. The construction is nearly complete, with equipment installation in summer of 2016.
This project replaces aging, outdate, unrepairable equipment with modular, energy efficient, wi-fi ready digital equipment. As the TERRA Band (fiber optic network for Western Alaska) makes it way north to Nome, KNOM is poised to take full advantage of greatly increased bandwidth capacity with digital production and broadcast equipment. Further, when fully functional, remote repair will be possible via a secure virtual network to diagnose and fix problems that may arise or be prevented.
All project expenses are capitalized to fixed assets.
To date, the multi-year capital campaign has raised \$855,906 of the \$1,000,000 goal.
Remodel of the "old" analog studios is underway in summer of 2016.

4b (Code: Programs) (Expenses \$ 948,077 including grants of \$ 0) (Revenue \$ 202,769)
KNOM continues to serve the people of Western Alaska. As internet becomes more available to the remote regions of Western Alaska, listeners are now consuming KNOM's content (including news, inspirational and local programming, with emphasis on Native culture) in two ways: radio and online. Listenership is now both actual and virtual.
Expenses include all ordinary program related costs, including in-kind contracted volunteer time (net) and trade-out bush airline tickets.
Revenues include in-kind gifts of contracted volunteer time (net) and underwriting revenues - both cash and trade-out bush airline tickets.

4c (Code: occ & supp) (Expenses \$ 14,670 including grants of \$ 0) (Revenue \$ 976,429)
98.5% of KNOM's revenues originate from postal mail. Online contributions are rising steadily, but will take a decade or more to constitute a significant portion of KNOM's donated income. A comparison test of mail service from the Lower 48 to Nome and back versus the Lower 48 to Anchorage and back showed an average delivery discrepancy of 2 to 4 weeks. This hurts fundraising potential, because donors do not bond to a charity that does not appear grateful for gifts by a slow acknowledgement of the gift. Further, security of Nome delivery was called into question several years ago.
Thus, KNOM set up a test office in Anchorage to accept mailed contributions, process and deposit the proceeds. The test showed positive results, and the board of directors voted to move the business and development office to Anchorage.
Now that the Anchorage business and development office has been established, the costs are outweighed by savings on labor and benefits, and further outweighed by gains in productivity and modestly increased ordinary income. (reversing 2 years of declines in ordinary donated income.)
