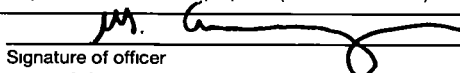

Grow school models - 20,000 new seats in 10 years initiative

Bluum assists the J.A. and Kathryn Albertson Family Foundation ("JKAF") determine where to make education investments that will result in the growth of high performing seats in Idaho. Once grants are made by JKAF, we monitor school growth, school financial results, school academic results and other metrics called out in the grants.

Accomplishments:

To date, Bluum has helped JKAF identify and provide grant support to eight schools in Idaho. The grants provide annual payments subject to the schools meeting agreed-upon annual targets including enrollment growth, academic results, financial stability and other metrics. These eight schools plan to add 4,673 new, high performing seats over the next 5-7 years.
