Grants for support of Moscow Theological Seminary (MTS). MTS operates in nine learning centers across Russia. MTS was established in 1993 and has a total enrollment of over 900 students. Since most students are bi-vocational, the satellite learning center model makes it possible to reach hundreds of students who can have an immediate impact on their churches and communities.
