THE SCHOOL CONTINUES TO PROVIDE AN EXCELLENT EDUCATION TO STUDENTS WITH LANGUAGE BASED LEARNING DIFFERENCES, MAINLY DYSLLEXIA. STUDENTS WILL TYPICALLY ATTEND THE SCHOOL FOR A 2 TO 4 YEAR REMEDIATION PERIOD, OR LONGER IF NEEDED, AND THEN OUTPLACE TO OTHER VARIOUS PUBLIC OR PRIVATE EDUCATIONAL SETTINGS.
