BCA offers cooking classes for families with children at risk for obesity, family camps for young children with type 1 diabetes, a transitions camp for young adults, a leadership training program, and online peer counseling training and support for children with chronic health conditions. The residential camps offer a wide range of challenging activities for campers to enjoy and offer educational seminars, led by our medical teams, to increase knowledge and self-management skills that give campers an understanding of their conditions and a much needed sense of control.
