St. Vincent Dunn Hospital is dedicated to providing spiritually-centered, holistic healthcare that sustains and improves the health of those served, with special attention to the poor and vulnerable. Both inpatient and outpatient health services are provided without regard to patient race, creed, national origin, economic status, insurance status or ability to pay. This mission extends well beyond the provision of core medical services to encompass medical and scientific research programs, the training and educating of health care professionals and active support of community-based partnerships and programs to improve health and quality of life.

	St. Vincent Dunn Hospital (SVDH) is a 25-bed, critical access hospital serving rural Dunn and contiguous counties and providing services without regard to patient race, creed, national origin, economic status, or ability to pay. SVDH provides inpatient and outpatient health care services with a 24-hour emergency department that is staffed with an on-site physician. During fiscal year 2016, SVDH treated 720 adults and children for a total of 2,618 patient days of service. The hospital also provided services for 29,508 outpatient visits, including 726 outpatient surgeries and 7,784 Emergency Room Visits. St. Vincent Dunn Hospital provides the following hospital services: Cardiovascular Services, Children's Health, Diabetes Care, Digestive Health, Emergency Care, Home Care, Immediate Care, Maternity Services, Medical Imaging, Orthopedics, Rehabilitation Services, Respiratory Care, Sports Performance, Surgery, and Women's Health. Some of these services operate at a loss in order to ensure that comprehensive services are available to the community. Community benefit is not the work of a single department or group within St Vincent Dunn, but is part of the St Vincent mission and cultural fabric. The hospital leadership team provides direction and resources in developing and executing the Implementation Strategy in conjunction with the St Vincent Health Community Development & Health Improvement Department, but associates at all levels of the organization contribute to community benefit and health improvement.

Hospital financial counselors and health access workers assist patients in determining eligibility and in completing necessary documentation. St. Vincent Dunn Hospital is committed to 100% access, and is proactive in providing healthcare that leaves no one behind. Public Program Participation: St. Vincent Dunn Hospital participates in government programs including Medicaid, SCHIP (Hoosier Healthwise), Healthy Indiana Plan (HIP), the Insurance Exchange and Medicare and assists patients in enrolling for programs for which they are eligible. Per Catholic Health Association guidelines and St. Vincent Health's conservative approach, Medicare shortfall is not included as community benefit. Community Health Needs Assessment: True community benefit responds to the particular needs and challenges of the community, building on its unique strengths and assets. The hospital leads a community health needs assessment every 3 years. Using a variety of tools, including surveys, key person interviews, focus groups, secondary data, and data analysis professionals, the team identifies community issues and concerns. These are shared with the community at large, and a consensus is reached about priorities and available resources. To provide community input and a basis for collaboration within the community to address health needs, St. Vincent leads or participates in a community roundtable or forum. This group brings together individuals and organizations from throughout the community who share a common interest in improving health status and quality of life and provide expertise in a variety of community areas including public health. Tobacco use and obesity have been identified as key community needs. Community Health Education: St. Vincent Dunn Hospital provides health education on a number of topics and issues facing the local community throughout the year. One such important topic is prescription drug abuse. St. Vincent Dunn Administrator, R. Ph. offers educational presentation throughout the community. During FY16, he provided continuing education for first responders in the Bedford and Lawrence County communities at the Lawrence County Sheriff's Department. Bariatric Support: Because maintaining a healthy weight can be a lifelong challenge, St. Vincent Dunn offers a free support group in two locations, Bedford and Bloomington, for anyone who has had, or is considering, bariatric surgery. These groups meet monthly for an hour and half with an average attendance between 10-15 individuals. Health Professions Clinical Training: In an effort to prepare future healthcare professionals, St. Vincent Dunn Hospital, in collaboration with area schools, offers a variety of clinical settings and internships for undergraduate and vocational allied health professionals. In fiscal year 2016, the surgery department provided training to students from Harrison College and Ivy Tech College, and Med Tech College wherein the students learned and carried out the duties of a surgical tech, radiology and ultrasound. Healthy Trails and Tails: Healthy Trails & Tails is a partnership between St. Vincent Dunn, Bedford Parks Department, and White River Humane Society. The group offers monthly walks through local park trails. The Humane Society brings 3-4 dogs to be walked and community members can bring their own dog. The hospital provides a healthcare professional to talk with participants about healthcare topics while walking. Car Seat Safety: Because approximately 70% of car seats are not used properly, St. Vincent Dunn partnered with Automotive Safety Program and hosted a free car safety seat clinic. Individuals, who had car seats that did not meet specifications for their child, were provided a new car seat, while supplies lasted. Wings for
