GRC PROVIDES THEM WITH SUPPORT AND SERVICES, AND GIVES 2,240 ELDERLY RESIDENTS OF ALL ECONOMIC LEVELS AN ENVIRONMENT THAT EMBRACES THEIR CREATIVITY AND CONTRIBUTIONS, AS WELL AS THE CHALLENGES OF AGING.
