Convalescent Hospital for Children and Orphan Asylum ("CHCOA") was formed for the sole purpose of providing financial support to other publicly supported organizations located in Hamilton County, Ohio that participate in the treatment of, or research into, diseases or disorders affecting children. During CHCOA's fiscal year of July 1, 2015 through June 30, 2016 (the year covered by this return), CHCOA provided financial support amounting to \$2,271,567 to Cincinnati Children's Hospital Medical Center ("CCHMC"), an Ohio not-for-profit pediatric hospital located in Hamilton County, Ohio. Such financial support is provided from expendable income received from investments of restricted and unrestricted funds. It is the policy of CHCOA to invest such assets, thereby increasing fund principal and enhancing future expendable income. CCHMC utilized the financial support from CHCOA to support the operating costs of its pediatric rehabilitation program, adolescent psychiatric services program, disability services program, psychology pain management program, psychology adherence program, special needs children program, adolescent psychology services program, and to support the general operations of CCHMC. Because of the direct financial support of CHCOA to CCHMC, CCHMC has been consistently able to reinvest in its programs and maintains a national position as one of the premier pediatric health care providers in the nation.
