Endowment assets include those assets of donor-restricted funds that the School must hold in perpetuity or for a donor-specified period(s). Under this policy, as approved by the Board of Trustees, the endowment assets are invested in a manner that is intended to achieve returns in excess of the rate of inflation over the investment horizon, achieve a balanced return of current income and modest growth of principal, minimize the probability of loss of principal over the investment horizon, and ensure the ability to meet all expected or unexpected cash flow needs. The School recognizes the importance of preservation of capital but also recognizes that some risk is necessary to produce long-term investment results that are sufficient to meet the endowment objectives. However, the School emphasizes that investment managers are to make reasonable efforts to control risk, and will be evaluated regularly to ensure that the risk assumed is commensurate with the given investment style and objectives. Investment managers are expected to adhere to the investment management styles for which they were hired and will be evaluated regularly for adherence to investment discipline.
