Such charitable financial support is provided primarily through expendable income generated by investments of endowment and other funds received by TCH. During the tax year July 1, 2015 to June 30, 2016, in fulfillment of this charitable mission, TCH provided financial support amounting to \$59,351,000 to Cincinnati Children's to support its charitable efforts in pediatric patient care and related research.
