PART IV, LINE 2B	AfC was part of a three agency fundraising coalition entitled Kids Come First A Campaign Coalition for Child Care Resources (the Coalition or KCF). AfC served as the host agency responsible for fiscal administration and custody of Coalition funds under an agreement effective July 22, 2008. Funds received net of associated Coalition expenses were originally to be allocated and distributed to each member agency according to a predetermined formula, generally one third of the net proceeds except those contributions designated by the donor for a specific member agency. In March 2012, the agreement was modified. It was determined that Phase 1 of the Coalitions fundraising was to be for the renovation of AfCs facilities, and Phase 2 and Phase 3 of the fundraising would potentially benefit the other two member agencies. Cash held on behalf of the Coalition is reported as both an asset and corresponding liability in these financial statements. During the fiscal year ending June 30, 2016, the Coalition members decided to liquidate the remaining assets of the Coalition in equal shares. Funds were disbursed to the three agencies in August and September of 2016 and the Coalition terminated. AfCs portion, \$15,452, is included in other income in the year ended June 30, 2016 and in accounts receivable at June 30, 2016.
