

LEARNING ENVIRONMENT AND EDUCATIONAL RESOURCES - In accordance with the specified wishes of donors, the Foundation provided enhanced learning experiences in the IT Digital Media Lab, Medical Technologies Lab, The Natural Resources Center Lab, and the Robotics Lab. These labs were outfitted with state of the art instructional tools, computer software, and related equipment. In addition, the Foundation funded the development of an IDEA Lab. The IDEA Lab is an entrepreneurial makerspace available to the general public to help spur economic development.

4b (Code:) (Expenses \$ 501,227 including grants of \$) (Revenue \$)

NEW CONSTRUCTION - The Foundation began fundraising for two new buildings on both Zane State College campuses in FY2010. The Paul R. Brown EPIC Center in Cambridge, OH, is a 36,000 sf multi-use facility with classrooms, laboratories, offices, and a large community room. The Advanced Science & Technology Center in Zanesville, OH, is a 46,000 sf building which houses the alternative energy, electrical engineering technology, information technology, robotics, digital media, and allied health laboratories. Both facilities have been highlighted by state and local officials as being an asset to our region.

SCHOLARSHIPS - Scholarships are essential to ensuring the educational attainment of Zane State College students. Many of the students here at the College come from generational poverty and, consequently, are first generation college students. The adult learners we serve are raising families while working several jobs, in addition to attending classes. Without the financial support these scholarships provide, many of our students would not be able to reach their educational goals. Each year, the Foundation helps approximately 150 deserving students. These funds transform the lives of our students and their families as they enter the local workforce with newly developed skills. The great majority of Zane State College graduates stay in the local area; therefore, the impact of these scholarships truly become an investment in the economic vitality of our communities.
