Our mission is to support and counsel our student-athletes so they will maximize their potential at U of L and be successful in preparing for their future lives. We will provide leadership for our student-athletes to inspire their achievement of the goals established in this mission statement. U of L's competitive athletics provide an outstanding leadership laboratory, and its high quality classroom instruction provides outstanding educational opportunities. It is our responsibility to assure that our student-athletes benefit from these educational and athletic experiences at U of L. To help accomplish our mission, we provide superior services to our fans and donors, the primary financial resources that support our program. These services result in the best opportunities for our student-athletes to participate in well-supported, competitive programs that bring renewed spirit to our campus, our alumni, and the Louisville community.

The University of Louisville Athletics Association (ULAA) enjoyed success across the board in 2015-16. The school saw 15 of its teams advance to postseason play. The men's cross country team tipped off the postseason success. The team finished seventh at the NCAA Championships, its best performance in school history and second top-10 showing on the national stage. Ernest Kibet led the Cardinals, finishing 18th for his first career top-20 finish in the NCAA Championship, earning All-American honors to wrap up his cross country career at Louisville. Football followed suit, capturing the Music City Bowl for the school's 10th bowl victory in program history. Lamar Jackson set a Music City Bowl record with 226 yards rushing and was named the game's MVP, leading the Cardinals to a victory over Texas A&M. Also during the fall, volleyball secured its first ACC crown by winning the regular-season championship. The team finished with a record of 25-7, 18-2 in conference play, and was ranked No. 15 in the AVCA Poll in the final week of play. Louisville's baseball team reached the NCAA Super Regional for the sixth time in the last 10 seasons. The Cardinals won their second straight ACC Atlantic Division championship while adding a pair of major awards for the second consecutive season - Dan McDonnell was named ACC Coach of the Year and Drew Hamington was honored as ACC Pitcher of the Year. Kelsi Worrell paced the women's swimming and diving team, which earned six ACC individual titles. The Olympian won the NCAA Championship in the 100-fly with an American Record and the 200-fly. Mallory Comerford was the NCAA silver medalist in the 200-freestyle. The Cardinals concluded the year ranked 29th in the final 2015-16 Learfield Sports Directors' Cup Division I standings.
