Tenant Education Program (TEP)-The Renters Rights Hotline continued to serve over 2,000 tenants, counseling callers on their rights and responsibilities as tenants in Oregon. We also held numerous workshops, formulating deeper relationships with Multnomah County libraries and schools to host workshops and reach a broader audience. Finally, we laid the ground work for some much needed capacity building for equipment upgrades, staff increases, and database support.

Housing Justice Program (HJP)-We successfully launched a local campaign declaring a RenterStateofEmergency in the city of Portland which led to the declaration from Portland's mayor of a housing and homelessness emergency to draw attention to the 48% of Portland renters who face unfair housing conditions with regard to no-cause evictions and rent-increases. We engaged hundreds of tenants in advocacy opportunities to speak with local legislators and seed the ground for a statewide campaign to end no cause evictions for good and lift the ban on rent stabilization. We also continued our work with the Welcome Home Coalition to add a ballot measure for the city of Portland to have a general obligation bond in the amount of \$258 million dollars to support affordable housing development.

Safe Housing Project and Leadership Development (SHP/LD)-The Safe Housing project organized multiple buildings in need of significant repairs in Portland working with local community organizations, tenants, and government officials. We also began the development of our Tenant Leadership Council, a group of tenant leaders who are actively engaged in advocacy and civic engagement opportunities led by CATs membership.
