WATER PENNFUTURE HAS CONTINUED ITS LONGSTANDING EFFORTS TO PROTECT WATER QUALITY IN PENNSYLVANIA BY PURSUING LITIGATION, ENGAGING IN THE REGULATORY PROCESS, AND MONITORING ACTIVITIES THAT IMPACT WATER QUALITY. IN THE LAST YEAR, PENNFUTURE HAS PURSUED LITIGATION THAT HAS RESULTED IN IMPROVEMENTS TO PENNSYLVANIA'S EROSION AND SEDIMENTATION PERMIT PROCESSES AND AFFIRMED THE VALIDITY OF A TOTAL MAXIMUM DAILY LOAD (TMDL) TO LIMIT WATER POLLUTION. PENNFUTURE HAS ALSO ACTIVELY MONITORED REGULATORY ACTIVITY RELATED TO MUNICIPAL SEPARATE STORM SEWER SYSTEM ("MS4") PERMITS, RIPARIAN BUFFERS, AND PIPELINES. PENNFUTURE HAS SUBMITTED NUMEROUS COMMENT LETTERS TO MUNICIPALITIES, THE PENNSYLVANIA DEPARTMENT OF ENVIRONMENTAL PROTECTION, AND THE FEDERAL ENERGY REGULATORY COMMISSION ADVOCATING FOR IMPROVED WATER QUALITY PROTECTION IN EACH OF THESE AREAS. PENNFUTURE HAS ALSO REVIEWED DISCHARGE MONITORING REPORTS FROM NUMEROUS NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM PERMITTEES TO ASSESS THEIR COMPLIANCE WITH PERMIT CONDITIONS. THROUGH THIS WORK (AND OTHERS), PENNFUTURE HAS HELPED TO PROTECT AND PRESERVE PENNSYLVANIA'S WATER QUALITY FOR PENNSYLVANIA'S CITIZENS AND FUTURE GENERATIONS.
