We ran a three-month-long program in Cincinnati, Ohio that was focused on turning great ideas into successful, brand-driven start-ups. newly revived in 2010, we annually select 8-10 companies for our program, with each receiving \$50,000 in seed funding, three months of mentorship, and the opportunity to pitch to angel investors and venture capitalists at the end of the program. Finally, we provide 14 two-bedroom apartments in the neighborhood to serve as housing for the founders of companies participating in the Branderly's three month accelerator program
