Small Business Program - Opportunity Fund raises funds from private and public sources to provide micro and small business loans, to business borrowers who don't have access to credit from traditional financial institutions or lack access to affordable financing products. Since inception, Opportunity Fund has made over 8470 loans totaling \$164 million in capital deployed to borrowers throughout California, the substantial majority of whom are low and moderate income and ethnic minorities. An estimated 6,000 people have been served.















4b (Code) (Expenses \$ 1,554,148 including grants of \$) (Revenue \$ 1,151)
Savings Program - Opportunity Fund administers a matched savings and financial education program in the San Francisco Bay Area. Since inception, Opportunity Fund has opened 5,741 savings accounts and mobilized more than \$20 Million in individual savings and matching funds. An estimated 5,500 people have been served.

4c (Code) (Expenses \$ 559,069 including grants of \$) (Revenue \$ 2,101,776)
New Market Tax Credits Program - In 2003, Opportunity Fund was certified by the U.S. Department of Treasury - Community Development Financial Institution Fund ("CDFI Fund") as a Community Development Entity ("CDE") under its New Market Tax Credit ("NMTC") program. As of June 30, 2016, Opportunity Fund has received a cumulative total of \$253 million of tax credit allocations. Opportunity Fund - through its subsidiary CDE, the LCD New Markets Fund, LLC - uses these allocations to attract new capital to support large real estate projects providing high community impact in low-income areas. As of June 30, 2016, Opportunity Fund has deployed \$231.6 million in qualified equity investments. An estimated 660,000 people have been served.
