Federal Income Taxes The Internal Revenue Service has ruled that the Board is exempt from federal income taxes under 501(a) of the Internal Revenue Code as an organization described in Section 501(c)(4). Accordingly, no provision for federal income taxes has been made in the financial statements. Accounting principles generally accepted in the United States prescribes recognition thresholds and measurement attributes for the financial statement recognition and measurement of a tax position taken or expected to be taken in a tax return. Tax benefits will be recognized only if the tax position is more-likely-than-not sustained in a tax examination, with a tax examination being presumed to occur. The amount recognized will be the largest amount of tax benefit that is greater than 50% likely being realized on examination. For tax positions not meeting the more-likely-than-not test, no tax benefit will be recorded. Management has concluded that they are unaware of any tax benefits or liabilities to be recognized at June 30, 2016 and 2015, and does not expect this to change in the next 12 months. The Board would recognize interest and penalties related to unrecognized tax benefits in interest and income tax expense, respectively. The Board has no amounts accrued for interest or penalties as of June 30, 2016 and 2015. The Board is no longer subject to examination by taxing authorities for the years before June 30, 2013 for federal and 2012 for state filings.
