The LAAC board delegated the executive compensation review and approval to the executive committee of the board, which consists of the Chair, Vice Chair, Sec'y and Treasurer of the board, all of whom are independent persons. The ED is not involved in the review and approval process. The committee reviewed comparable executive compensation packages in the broader nonprofit sector and the legal services nonprofit sector, using data from several sources. The board used the information in those studies and considered LAAC's annual budget and the possibility of significant increases or decreases in revenue in making its compensation offer. The ED had an annual review in May 2016. All board members had the opportunity to submit input.
