The Child and Adult Care Food Program is funded by U S Dept of Agriculture through California Department of Education. This program reimburses child care providers for the nutritious meals they serve to the children in their care. CDA currently sponsors approximately 1,277 Family Child Care Homes throughout San Diego, Orange, Riverside, San Bernardino Counties, Imperial Counties, and a portion of Los Angeles County

Through a contract with San Diego County Office of Education, CDA has been designated as the San Diego County Quality Preschool Initiative (SDCQPI) reimbursement agency. All expenses receive prior approval and are then reviewed by two different people within the accounting department. A third person reviews each expense for proper classification and fiscal reporting. We have six authorized check signers and each check requires two signatures. When possible, all checks must be first signed by the CEO.
