ACE AND THE NATIONAL SENIOR GAMES ASSOCIATION (NSGA) PARTNERED TO BEGIN THE DEVELOPMENT OF RESOURCES AND TOOLS TO HELP AMERICANS OVER 50 YEARS OLD LEAD HEALTHY AND FIT LIVES. NSGA IS A 501(C)3, NON-PROFIT, CORPORATION DEDICATED TO PROMOTING HEALTHY AND ACTIVE LIFESTYLES FOR ATHLETES AGE 50 AND OVER, AND IS A RECOGNIZED MULTI-SPORT ORGANIZATION OF THE UNITED STATES OLYMPIC COMMITTEE. ACE AND YMCA OF USA TEAMED UP TO ENHANCE THEIR IMPACT ON COMMUNITY HEALTH. ACE DEVELOPED AND PROVIDED YMCA HEALTH AND WELLNESS PROFESSIONALS WITH A SERIES OF CUSTOMIZED EDUCATION AND TRAINING IN GROUP EXERCISE AND STRENGTH AND CONDITIONING TO COMPLEMENT THE Y'S METHOD FOR CONDUCTING HEALTH AND WELLNESS CLASSES. THE SERIES OF FOUNDATIONAL COURSES HELP TO ENSURE THAT Y PROFESSIONALS HAVE THE EDUCATION AND TOOLS TO SUPPORT PEOPLE IN ACHIEVING THEIR GOALS FOR HEALTH AND WELLBEING. ACE AND THE AMERICAN HEART ASSOCIATION/AMERICAN STROKE ASSOCIATION'S EMPOWERED TO SERVE MOVEMENT FORMED A PARTNERSHIP TO BETTER IMPACT HEALTH OUTCOMES IN MULTICULTURAL COMMUNITIES ACROSS THE COUNTRY.
