In the past year, our Christian Children's Home of Ohio residential program and our Encompass foster care program had the opportunity to directly serve 142 children. Nearly all of these children have experienced trauma at some level which has made an impact on their lives. Our trauma informed staff help these children work through the trauma and help the children recognize their worth. Our Encompass Adoption program finalized 6 adoptions last year. Our licensed clinicians in our Encompass Christian Counseling Centers and In-home Services programs were able to directly serve 1407 children and adults, providing nearly 22,000 hours of mental health treatment. Poplar Ridge Stables, our equine program on campus, completed 1248 therapeutic sessions. All this programming was graciously supported by 829 volunteers who volunteered 4653 hours to help CCHO/Encompass meet the needs of their clients.
