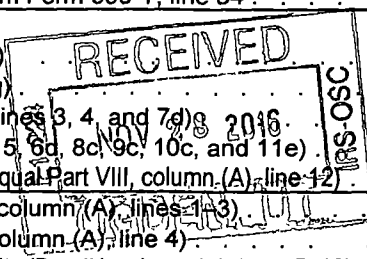

4a (Code: ) (Expenses \$ 154,469 including grants of \$ ) (Revenue \$ ) Human Rights Issue Education, Social Action, and Advocacy Programs: Inspired by Pope Francis's 2015 visit to the U.S., a record-breaking 1,600 students and young adults gathered for the 18th annual Ignatian Family Teach-In for Justice November 7-9, 2015 in Washington, D.C. "Bridges" was a fitting theme for the gathering: connections were built, ideas were forged and friendships were made among the participants from Jesuit universities, high schools, parishes, and the larger Catholic Church. On the final day, over 1,200 participants went to Capitol Hill to meet with nearly 125 Congressional offices. Advocates participated in meetings with lawmakers and staffers to urge Congress to support human rights-oriented policies in Central America, pass humane comprehensive immigration reform, and respond to climate change negatively impacting the poor across the world. (continued on Schedule O)

4b (Code: ) (Expenses \$ 144,784 including grants of \$ ) (Revenue \$ ) Faith-Based Social Justice Leadership Development & Affirmation: ISN hosted three leadership summits for high school students and faculty across the country in Spring 2015. Named after the late Pedro Arrupe, S.J., former leader of the Jesuits internationally, the Arrupe Summits offer students and teachers the opportunity to explore the relationship between service, social justice, faith, and leadership. Over 150 students from Jesuit and partner Catholic high schools across the U.S. and Canada participated in the summits which took place in California, Ohio and Maryland. In July, 2015, ISN hosted 30 Jesuit college and university students for a 4-day/3-night social justice leadership summit grounded in Ignatian spirituality and the values of Jesuit education. The summit provided student leaders from more than a dozen Jesuit schools across the country an opportunity to develop effective justice leadership skills and increase their understanding of the relationship between Jesuit mission and social justice. 4c (Code: ) (Expenses \$ 110,086 including grants of \$ ) (Revenue \$ ) Communications and Network: The Ignatian Solidarity Network continues to grow the ways it networks, educates, and forms advocates for social justice digitally and in print materials. ISN's website (www.ignatiansolidarity.net) welcomed nearly a quarter million visitors in 2015-2016, a 27% increase from the previous year. On the site users found social justice news from the Ignatian network, moving blog posts written by a diverse range of authors - including a special series entitled "JV Reflects" featuring current Jesuit Volunteers placed domestically and internationally - and education and advocacy resources on key justice issues. In September, 2015, over 40,000 people engaged in ISN-sponsored Pope2Congress watch parties, uniting Catholics throughout the U.S. in an experience of reflective listening and dialogue as Pope Francis addressed Congress at the U.S. Capitol. In total, there were 347 watch parties that utilized Pope2Congress bingo cards distributed by ISN in print and digitally to Catholic schools, parishes, religious communities, etc. (continued on Schedule O)

ISN distributed resources to be used in hosting the masses. Other Pope2Border activities included in-district visits with members of Congress, community dialogues on migration policy, building "mock border walls" to bring awareness to the plight of migrants, and the signing of a letter to Catholic members of Congress calling for humane

border policies. In partnership with Solidarity Ignite, ISN hosted two apparel workers from the Dominican Republic-based Alta Gracia living wage apparel factory. The worker tour visited 27 schools in 12 different states where they raised awareness about ethical consumerism and the positive implications of a living-wage oriented apparel model. The workers closed out their tour by presenting at the Ignatian Family Teach-In for Justice.

(continued) Also in July, 2015, ISN hosted the first-ever Jesuit Parish Social Justice Gathering, creating a space for staff and volunteers at Jesuit parishes engaged in social justice ministry to gather and learn from each other. Attendees represented a dozen different Jesuit parishes across the U.S. ISN recognized Fr. Michael Garanzini, S.J., former president of Loyola University Chicago, with the Robert M. Holstein Award. Named after the late ISN co-founder Bob Holstein, the award honors those who have demonstrated a significant commitment to leadership for social justice. Previous award winners include Sr. Carol Keehan, D.C.; Fr. Jim Connor, S.J.; Fr. Charlie Currie, S.J.; Fr. Stephen Privett, S.J.; Fr. Donald MacMillan, S.J.; and Sr. Helen Prejean, C.S.J. ISN also honored Kevin and Trena Yonkers-Talz with the Legacy of the Martyrs Award, which honors individuals who have lived out the legacy of the Jesuit martyrs and their companions killed in El Salvador in 1989. Previous award winners include Rep. Jim McGovern, Equipo de Reflexion, Investigacion y Comunicacion (ERIC) and Radio Progreso, a Jesuit-sponsored organization in Honduras whose work encompasses grassroots radio programming, human rights training, community organizing, and assisting migrant families; and Kino Border Initiative, a Jesuit ministry on the U.S.-Mexico border working for the dignity of migrants through accompaniment, advocacy and education.

2015-2016: "Stay in Love" is a guide for recent alumni seeking to stay involved with the Ignatian network after graduation. The 8-page booklet includes a listing of Jesuit parishes, retreat center, spirituality and service programs, and ways to connect with ISN's education and advocacy opportunities. Over 4,000 of the booklets were distributed in spring of 2016.

"Stay in Love" also has a tandem website with additional resources. "Ignatian Advocacy 101" is a training resource for students and faculty seeking to form other skills to be effective legislative advocates on key justice issues. The 32-page booklet offers a step-by-step guide to facilitate legislative advocacy training as well as sample materials to enact a legislative advocacy meeting. In partnership with Jesuit Volunteer Corps, ISN hosted hundreds of young adults at Solidarity on Tap events across the country, in cities like Philadelphia, Chicago, San Francisco, Cleveland, Baltimore, and Detroit. Solidarity on Tap is a simple gathering at a local pub for socializing and social justice that welcomes Jesuit school alumni, Jesuit parish members, current & former Jesuit Volunteers, Ignatian Volunteer Corps members, Jesuit institution staff, Jesuits, and friends of the Ignatian network. Gatherings include a social justice speaker who offers faith and justice reflection.
