DURING THE 2015-16 SEASON, THE 72ND SEASON OF THE TOLEDO SYMPHONY, AUDIENCES CAME TOGETHER FOR A SINGULAR REASON TO EXPERIENCE THE POWER OF LIVE SYMPHONIC MUSIC. TOTAL AUDIENCES TOPPED 250,000 ACROSS PERFORMANCES OF ALL TYPES. IN OUR RESPIGHI-THEMED CLASSICS CONCERT, ROMAN ADVENTURE, LIVELY INTERPLAY BETWEEN ANTIPHONAL BRASS AND THE ORCHESTRA ENVELOPED THE AUDIENCE WITH SOUND. THIS PROGRAM, COMBINED WITH LARGE TSO IN HD SCREENS, CONNECTED AUDIENCE MEMBERS WITH THE MUSICIANS LIKE NEVER BEFORE. ANOTHER SPECIAL EVENT, VIDEO GAMES LIVE, WAS AN IMMERSIVE CONCERT THAT FEATURED MUSIC FROM THE MOST POPULAR GAMES OF ALL TIME. THIS PERFORMANCE DREW A FULL HOUSE OF AFICIONADOS YOUNG AND OLD. THE 2015-2016 SEASON ALSO MARKED THE EXPANSION OF A DECADES-LONG PROGRAM WITH TOLEDO PUBLIC SCHOOLS. IN ADDITION TO HAVING ALMOST 1,700 TPS 4TH GRADE STUDENTS ATTEND A SCHOOL-DAY PERFORMANCE AT THE PERISTYLE, TOLEDO SYMPHONY MUSICIANS VISITED OVER 40 ELEMENTARY SCHOOLS PRIOR TO THE PERFORMANCE TO DISCUSS THE REPERTOIRE AND TALK ABOUT THEIR EXPERIENCES IN SCHOOL BANDS AND ORCHESTRAS. IT WAS INSPIRING FOR THESE STUDENTS TO MEET OUR PROFESSIONAL MUSICIANS AND LEARN ABOUT THEIR MUSICAL DEVELOPMENT. WE CONCLUDED A MONTH-LONG MOZART FESTIVAL IN APRIL WITH A SPECIAL PERFORMANCE OF MOZART'S GORGEOUS REQUIEM. THE ORCHESTRA WAS GRATEFUL TO PERFORM SUCH A POWERFUL PIECE AND HONORED THAT OUR PERFORMANCE MADE SUCH A DIFFERENCE IN PEOPLE'S LIVES. THE END OF THE SEASON MARKED THE BEGINNING OF CHANGE AT THE TOLEDO SYMPHONY. PRESIDENT AND CEO, KATHLEEN CARROLL, RETIRED FROM 27 YEARS OF SERVICE TO THE ORGANIZATION AND COMMUNITY. AS SHE PASSES THE BATON, WE WILL STRIVE TO CONTINUE THE TRADITION THAT HAS KEPT OUR TOLEDO SYMPHONY A MAINSTAY OF THE REGION AND PROPEL OUR ORGANIZATION TO THE FUTURE WITH ENDURING STABILITY AND RELEVANCE.
