Ryves Youth Center at Etling Hall served over 1,300 youth in activities such as sports, scouting, preschool, Kids Cafe’, tutoring, reading and backpack distribution. Ryves Youth Center offers crisis intervention, free meals, cooking and food service training, preschool, tutoring, Scouts, organized sports, music program, financial counseling and computer training in our computer lab. Breakfast and lunch are served to the preschool for homeless and at-risk children and an evening meal is served to the regular latch-key children. All of our meals and programs are at no charge.

The Bethany House shelter provided temporary shelter for single women, married couples and families, case management, referrals and skills development serving 45 adults and 14 children. The Loaves and Fishes Soup Kitchen served over 41,000 meals and Deli Days served over 4,000 people. The Clothes Closet provided gently used clothing and small household items to 7,327 family members.

The Christmas Store provided new gifts to almost 1,000 low-income families.
