Pt I Line 2	Each grant applicant provides a detailed budget with their proposal. The Foundation receives two progress reports during the grant period from each funded researcher. From these reports, the Foundation is able to determine if the project is progressing as proposed and funds are being spent as detailed. Most of the funds go to the funded university to cover graduate student salaries. The remainder goes to the researcher to purchase supplies needed to support the project.
