Lake Forest Academy (LFA) represents the 1974 merger of the original Lake Forest Academy, a boys' preparatory school founded in 1857, and Ferry Hall, a girls' preparatory school founded in 1869. Today's LFA is home to 435 students from 18 states and 36 countries where 48% are boarders. LFA operates as a boarding school with 74% of the teaching faculty residing on campus. LFA's campus is the former estate of J. Ogden Amrour which underwent adaptive reuse in 1948 to house the present school. Over the course of 70 years the school has grown and kept pace with educational demands, both in teaching practices and technology. LFA is guided by a Board approved strategic plan that reaffirms its mission representing four pillars: character, scholarship, citizenship and responsibilities. A new vision embracing global pluralism helps not only distinguish LFA among schools, but is a frequent lens by which progress on character, citizenship, and responsibility are measured and evaluated. Increasing demand for admission, enviable college placement, a strong financial position, plus a strong commitment to financial aid are the hallmarks of who we are: financially stable, diverse and a full school with top-ranked students, making LFA one of the leading boarding schools in the Midwest.
