Tobacco Control Reduce smoking rate, reduce exposure to secondhand smoke and prevent youth from using tobacco In 2016, Respiratory Health Association worked on Healthy Lungs Initiative, in collaboration with the Cook County Health and Hospitals System, to provide counseling and other resources to smokers who want to quit Through partnerships with the city and county, as well as with private businesses and other local health departments and hospitals, Respiratory Health Association provides "Courage to Quit" smoking cessation classes and "Intro to Tobacco-Free Living" workshops for adults, as well as the "Operation Storefront" curriculum, that encourages youth to make the choice to stay tobacco-free In addition, Respiratory Health Association works with health departments and other community stakeholders to promote smoke-free environments, including smoke-free housing These programmatic efforts are complemented by several policy initiatives to increase smoke free environments, extend smoke-free laws to include the use of e-cigarettes, secure passage of laws raising the purchase age for tobacco products from 18 to 21, and resist efforts to create exemptions in the Illinois Clean Indoor Air Law, which we helped pass in 2007
