The facility includes a unit serving patients with co-occurring mental health and substance abuse disorders with a particular focus on post-traumatic stress disorder and the Flonan Program, a specialized unit for firefighters and paramedics. Rosecrance Hamson Campus provided services to 3,500 clients.

Rosecrance Griffin Williamson Campus serves adolescents ages 12 to 18 for detoxification needs and inpatient substance abuse treatment. Clients participate in a 12 Step-based program that incorporates clinical, medical, educational and experiential therapies into comprehensive, individualized treatment plans. Rosecrance Griffin Williamson Campus provided services to 800 clients.

Rosecrance Ware Center offers outpatient services for adult behavioral health clients. The facility includes the Recovery Resource Center, where clients can access computers and recovery materials, as well as opportunities for peer support, mentoring and community volunteerism. The Ware Center moved to newly renovated space in November of 2014. The larger space has allowed for program expansion and diversification of services provided. The building was designed to specifically meet the needs of the clients and staff. Rosecrance Ware Center provided services to 6,100 clients.
