The competitive market data provided by the third-party firm in 2014 was updated in April/May 2015 by IES Abroad's Associate Vice President of Human Resources following compensation review best practices including guidance provided by the third-party firm. The Human Resources Department annually monitors salaries of all headquarters, U.S. based employees based upon the review of several national, third-party compensation survey reports. Once approved by the Board Executive Committee on an annual basis, compensation decisions made by the Executive Committee for vice presidents are presented to the full board of directors. Separately, the Executive Committee of the Board recommends compensation for the President/CEO to the full Board that in turn votes on the President's/CEO's compensation. The full Board votes on the compensation of the President/CEO on an annual basis. Vice presidents and officers never take part in the discussions regarding the setting of their own compensation. The chair of the Board of Directors documents the above process to the department of Human Resources on an annual basis. The compensation package of some of the organization's vice presidents and officers are documented in a written employment contract.
