The Marklund Day School in Bloomingdale serves children ages 3-22 with multi-needs, and has a specialized educational program for children with Autism. The NEW state-of-the-art building that opened in December 2015 allows for an expansion of the Autism program and a well designed and structured transitional program with a primary goal of providing support to neighboring school districts. Marklund is also home to the nationally recognized respite training program - called REST (Respite Education and Support Tools). REST provides training program for community-based respite companions.
