The SwedishAmerican Foundation is the fund development and charitable gifts arm of the SwedishAmerican Health System. The Foundation solicits and collects gifts from individuals, organizations, and corporations primarily within the greater Rockford community and surrounding counties, and uses that money to create and support programs and programming which help make the greater Rockford area a healthier place within which to live, work, worship and raise families, and to assist SwedishAmerican Hospital and its subsidiaries in the provision of superior care for its patients.

SwedishAmerican Foundation (SAF) supports SwedishAmerican Hospital, a 501(c)(3) organization in its mission to provide quality medical healthcare to communities in Northern Illinois and Southern Wisconsin regardless of race, creed, sex, national origin, handicap, age or ability to pay. During the current year, SAF provided funding grants to specialized departments which helped enhance patient care and patient-visitor comfort. In addition, earnings from the Chaplaincy Endowment, has partially subsidized the cost of the Pastoral Care department chaplains who specialize in providing counseling and spiritual guidance for patients, their families, and hospital staff.

During 2016, SwedishAmerican Foundation provided \$75,500 in grants and more than \$209,000 in sponsorships to community organizations whose vision and mission closely mirrors those of SwedishAmerican Hospital and SwedishAmerican Foundation.

In 2005, the SwedishAmerican Foundation (SAF), as part of its mission to revitalize the neighborhood surrounding the SwedishAmerican Hospital campus, purchased and renovated a group of run down rental housing units directly across the street from the hospital campus, for the purpose of providing safe, secure, and affordable near-campus housing for on-call hospital staff and medical students from the University of Illinois Rockford campus who are interning at SwedishAmerican Hospital. Program expenses relating to this mission project include the services of a salaried property manager in addition to all of the rental unit expenditures relating to repairs, maintenance and utilities which are also provided by SAF.
