PROGRAM SERVICE ACCOMPLISHMENTS On annual basis, provide additional funding support to Promising Young Surgical Investigators within the Departments of Surgery at the University of Minnesota, Regions Hospital of St. Paul, the VA Medical Center of Minneapolis, and other Academic Surgical Training programs throughout North America 2015-2016 Program Service Accomplishments The Programmatic Service Accomplishments for Fiscal Year 2015-2016 include providing additional funding support, resources, training and infrastructure, to promote, sponsor, and facilitate Basic and Applied Research in 21 surgical sub-specialty areas at Nationally recognized Academic Surgical Training Programs (ASTP) The Banatric and Metabolism Surgery Research Center, under the direction of Dr. Henry Buchwald, is the research tail of the internationally recognized POSCH Study. The POSCH Study of more than \$100,000,000.00 is the largest research grant ever given by the National Institutes of Health (NIH). For the first time, obese patients around the world are able to significantly reduce their morbidity and mortality secondary to hypercholesterolemia. This year, and working in cooperation with the National Football League Players Association (NFL/PA), the Living Heart Foundation (LHF), [a non-profit medical research foundation], and Athletes Health (AH), [a for-profit consortium], continued their 13-year Medical Screen Program providing quarterly screening and follow-up care to members of the NFL Former Players. No one participates at the NFL level that doesn't come out compromised in physical or emotional fashion. The National Football League/Players Association is instrumental in identifying players most in need, directing them to quarterly screening clinics conducted throughout the country and paying for their care under the direction of the Living Heart Foundation and in cooperation with Signature Health under the direction of the University of Minnesota Physicians (UMP) at the University of Minnesota. -2-In September, 2016, we are conducting a National Symposium gathering former players, current players, their families, representatives of the NFL, representatives of the Minnesota Vikings, the Metropolitan Sports Authority, and members of the Scientific and Medical Community focusing attention on Traumatic Brain Injury (TBI), the result of unrecognized and untreated cerebral concussion continues to plague the ranks of NFL players. The Plastic and Reconstructive Surgery Program under the direction of Dr. Umar Chaudry offers a three-year Surgical Fellowship Training in Plastic and Reconstructive Surgery highlighting specialty surgical repair in limb, organ, facial reconstruction, and organ transplantation. The Plastic Surgery Research Center Training Program continues to work at the National levels focusing on aesthetic and plastic and reconstructive surgery to enhance the quality of life for patients following accident or surgical oncology procedures. This year, after more than 35 years of distinguished service, Bruce L. Cunningham, MD, Division Head retired. Under Dr. Cunningham's leadership research and training programs grew significantly. In a fitting gesture, Dr. Cunningham's colleagues, students, and many friends created the Bruce L. Cunningham, MD Retirement Fund designated for trainees within the Plastic and Reconstructive Surgery Program. The resources and means to travel to national meetings, present their findings, and assume positions within the National organization of the American Society of Plastic Surgeons (ASPS). The Fellowship continues the ongoing partnership with Dr. Roxanne Guy, Melbourne, Florida, representing the Brevard Plastic Surgery Educational Travel Fund. With the recent graduation of Dr. Jennifer Cameron, Dr. Cameron has taken a major leadership position with Dr. Brian Kobenia to raise additional funds in support of the Residents Training Experience outside the research laboratory. Surgical Residents are finding it more difficult, without significant infrastructure in place, to operate within the confines of the University of Minnesota. Dr. Cameron will address, in a substantive way, the changing work environment including scheduling, meals, and other amenities, such as medical dictation, transcription, and charting to enhance the residents' experience. The Metabolism Surgery Research Center, under the direction of Dr. Roderick Barke, offers outstanding metabolism and wound-healing research coupled with surgical treatment for approximately 5,000 patients each year at the VA Medical Center of Minneapolis. -3-Dr. Barke, working in cooperation with his colleague, Dr. Linda Carson, is further integrating the metabolic research program into the Obstetrics and Gynecological Training Program at the University of Minnesota with an emphasis on Gynecological Surgical Oncology. With Dr. Barke's retirement from the VA Medical Center, Dr. Steven Santilli, was selected as Chairman of the Department of Surgery. IBARS is pleased to acknowledge Dr. Santilli has accepted an offer to join the IBARS Board of Directors. The International Humanitarian Surgical Team, under the direction of Dr. Warren Schubert and Mrs. Naomi Quillopa, RN, working in close cooperation with the Judith Lombeida Foundation plans, finances, and implements life-saving medical missions to Central and South America (Ecuador and Mexico) coupled with recent medical missions to the Philippines and the Far East. The International Humanitarian Surgical Team represents the Surgical Training Program in Plastic and Hand Surgery at St. Paul Regions Hospital. Each year, more than 50 physicians and para-professionals attend the medical and surgical needs of more than 1,500 indigenous patients performing significant, and in some cases, life-saving facial reconstructive surgery. The Najarian Research Center, under the direction of Dr. John Najarian, continues to showcase the talents of world-renowned organ transplant surgeon, Dr. John Najarian. For more than 50 years, his legacy trainees have led the nation in the field of solid organ transplantation. His center provides resources, including travel to national and international conferences. Dr. Najarian is a recognized world leader training Transplant Fellows whose numbers now exceed 214. Recently, the IBARS Board of Directors extended an invitation to Dr. Najarian's son, Mr. Peter Najarian, to become the Acting Chair of the Board of Directors. This is part of the 4-year continuous improvement succession plan working in cooperation with our 5-year Long-Range Plan to effect smooth transition at the Senior Leadership Level. Veterans of Foreign Wars and its Ladies Auxiliary Center Research Center, under the direction of Dr. Todd Tuttle, provides funding for the Veterans of Foreign Wars and its Ladies Auxiliary Surgical Oncology Research Award at the University of Minnesota. Each year, the VFW and its Ladies Auxiliary Surgical Oncology Research Award is given to an Outstanding Young Surgical Investigator with an extraordinary capacity for contributions to the field of Surgical Oncology during the Research Laboratory portion of their training experience. -4-The St. Paul Regions Personnel Travel Fund, under the direction of Dr. Martin Lacey, provides support including ongoing operational support, invited outside speakers, and national travel, for surgical residents within the Plastic and Hand Surgery Training Program at St. Paul Regions Hospital. Dr. Lacey, working in cooperation with the St. Pauls Regions Personnel Travel Fund, under the direction of Dr. Warrant Schubert, surgical fellows, surgical residents, medical students, and professional staff members travel to national conferences in support of the Division of Plastic and Hand Surgery. Three programs developed during Fiscal Year 2014-2015 have expanded during the recent Fiscal Year 2015-2016. They include: The William R. Kennedy, MD Neurologic Research Center, under the direction of Dr. William Kennedy, in the Neurology Program at the University of Minnesota. Dr. Kennedy is recognized as the world's leading authority in the area of primary peripheral neuropathy secondary to Juvenile (Type 1) and Adult (Type 2) onset diabetes. Dr. Kennedy and members of his research team are studying this problem to find a treatment to ameliorate peripheral diabetic neuropathy. The Vascular Surgery Fellowship Fund under the direction of Dr. Rumi Faizer, continues in support of the Vascular Surgery Training Program at the University of Minnesota, offering opportunities for Outstanding Vascular Surgical Fellows to attend National and International Conferences, coupled with expanded training opportunities for medical students, surgical residents, staff and faculty members. Operational funds were used for the purchase of new computer equipment. Perhaps the most significant development was the advancement, in cooperation with the University of Minnesota, and the Wangenstein Society to significantly expand funding for the Surgical Resident.
